

## THIS CONTEST IS OPEN TO ALBERTA RESIDENTS WHO ARE CUSTOMERS OF ALBERTA CO-OPERATIVE ENERGY ONLY AND IS GOVERNED BY CANADIAN LAW.

## 1. CONTEST PERIOD:

Contest begins on July 15, 2020 at 12:01 a.m. MDT and ends on September 30, 2020 at 11:59 p.m. MDT (the "Contest Period").

## 2. ELIGIBILITY:

Contest is open to all legal residents of Alberta who are eighteen (18) years of age or older and are customers of Alberta Co-operative Energy (ACE), at the time of entry, except employees, representatives or agents (and those with whom such persons are domiciled) of Alberta Co-operative Energy (the "Sponsor"), its parent companies and the Contest judges (collectively, the "Contest Parties").

#### 3. HOW TO ENTER:

NO PURCHASE NECESSARY, HOWEVER YOU MUST BE AN ALBERTA CO-OPERATIVE ENERGY CUSTOMER. To enter, Alberta Co-operative Energy customers must Refer a New Customer\* to ACE Before Sept 30, 2020 and in addition to your Referral Credit, you will both (the referring customer and the new customer) be entered in the Bonus Draw for a Chance to Win \$1,000 Credit towards your future ACE invoice (no cash value). Alternatively potential customers who like our rates and want to sign up\*\* with ACE may do so before September 30, 2020 and be entered in the Bonus Draw for a Chance to Win \$1,000 Credit towards your future ACE invoice (no cash value).

To become an ACE Customer:

- You must be an Alberta resident,
- Over 18 years old,
- Eligible to sign up for Energy Services, for an ACE service eligible site
- Pass a Credit Check (if required),
- Successfully enroll as an Ace customer consuming energy through ACE.

To be eligible, your Entry must be received within the Contest Period. All eligible Entries received during the Contest Period will be entered into the random prize draw (see Rule 5).

There is no limit of the number of times an Alberta Co-operative Energy customer may receive the automatic entry for Referring a New Customer\*, however each New Customer\*\* is limited to one entry per sign up. For greater certainty, a New Customer\*\* will only be entered once upon successful sign up with Alberta Co-operative Energy and must be consuming energy through ACE by Oct 6, 2020.

<sup>\*</sup>The Referred Customer must successfully sign up with ACE, provide an ACE Customer's name as reference and be consuming energy through ACE by Oct 6, 2020 to be eligible for entry in the draw.

<sup>\*\*</sup>New Customers must successfully sign up with ACE and be consuming energy through ACE by Oct 6, 2020 to be eligible for entry in the draw.



If it is discovered that you have attempted to circumvent the rules of the Contest; then (in the sole discretion of the Sponsor) you may be disqualified from the Contest and all of your Entries may be voided. Your Entry will automatically be rejected if the entry form is not submitted during the Contest Period. Use of any automated system to enter or otherwise participate in this Contest is prohibited and will automatically result in disqualification.

There will be one (1) prize available to be won as follows:

The prize will consist of \$1,000.00 credit towards your future Alberta Co-operative Energy invoice (no cash value).

Disclaimer: the \$1,000.00 credit will be shown on the Winner's Alberta Co-operative Energy Invoice (as a credit to be applied to their billing).

Delivery: The Winner will be contacted by Alberta Co-operative Energy on or about October 7, 2020 following the random draw and will be required answer a skill testing question. The prize must be accepted as awarded and is not transferable or convertible to cash (no cash value). No substitutions except at Sponsor's option. The Sponsor reserves the right, in its sole discretion, to substitute the prize or a component thereof with a prize of equal or greater value, including, without limitation, but at the Sponsor's sole discretion, a cash award. The prize will only be awarded to the person whose name and valid address (email or physical) appear on their customer sign up form. The Sponsor is not responsible if the event is cancelled, delayed, or rescheduled for any reason. The winner is solely responsible for all costs not specifically mentioned above as included in the prize description.

## 5. RANDOM PRIZE DRAW AND WINNER SELECTION:

On October 7, 2020 (the "Draw Date") in Thorhild, Alberta at approximately 1:00 p.m. MDT, one (1) eligible entrant will be selected by random draw from among all eligible Entries received during the Contest Period. The odds of winning depend on the number of eligible Entries received during the Contest Period.

The Sponsor or its designated representative will make three (3) attempts to contact the selected entrant(s) by telephone or email (using the information provided at the time of customer sign up) within three (3) business days of the Draw Date. If a selected entrant cannot be contacted within three (3) attempts or three (3) business days of the Draw Date (whichever occurs first), or there is a return of any notification as undeliverable; then that selected entrant will be disqualified and the Sponsor reserves the right, in its sole discretion and subject to time constraints, to randomly select an alternate eligible entrant from among the remaining eligible Entries.
